A well-equipped Seminar Hall with air cooling, a Stage with seating arrangement with dice and Whiteboard with a projector.

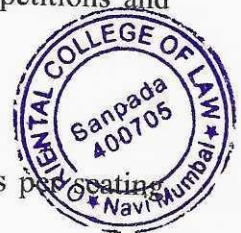
