Objective:

Pre-Event Preparations:

3. Post-Donation Care:



DESCRIPTION OF ACTIVITY	<p>Swachh Bharat Abhiyan (Clean India Mission) is a nationwide campaign initiated by the Government of India with the goal of making India clean and free of open defecation. It emphasizes sanitation and proper waste management practices across the country. Oriental College of Law actively participated in this initiative by organizing a cleanliness drive within and around the college campus.</p> <p>This drive was designed not only to clean the physical environment but also to educate students, staff, and the local community on maintaining hygiene and contributing to a cleaner nation. The event was a collaborative effort between the students, faculty, and administration, demonstrating the college's commitment to social responsibility.</p> <p>The event commenced with an inauguration ceremony at 9:00 AM. The Principal of the Oriental College of Law, Dr. Anil Kumar, addressed the students, faculty members, and volunteers. students were assigned to different zones of the campus, including classrooms, the library, canteen area, and outdoor spaces like lawns and parking areas. Equipped with gloves, brooms, garbage bags, and dustbins, the students enthusiastically removed litter and cleaned the surfaces.

Dustbins were placed at regular intervals, and posters promoting cleanliness were put up across the campus as a reminder of maintaining hygiene on a daily basis.

1. **Neighborhood Cleanliness Drive:** A group of students, along with faculty members, moved to the streets surrounding the college. The neighborhood clean-up focused on garbage collection, cleaning public spaces, and segregating waste into biodegradable and non-biodegradable categories. This activity served to spread awareness among the local community about proper waste disposal.
2. **Awareness Campaign:** Posters and banners were placed around the college, spreading messages about the importance of cleanliness, waste segregation, and environmental sustainability. - The waste collected was properly segregated, with biodegradable waste sent for composting and non-biodegradable waste disposed of through proper channels.
- The plantation of saplings added greenery to the college surroundings and instilled a sense of environmental responsibility among the participants.


The feedback from students and faculty was overwhelmingly positive. **Neha Sharma**, a 3rd-year law student, stated, "The event not only made us more aware of the cleanliness issues around us but also gave us a sense of fulfillment in contributing towards a national mission. It was a rewarding experience."

Prof. Meenakshi Patel, one of the faculty volunteers, highlighted the importance of such drives in shaping students' holistic development: "These activities teach students responsibility, teamwork, and the importance of being socially conscious individuals."

The Swachh Bharat Abhiyan conducted by Oriental College of Law was a resounding success. It served its dual purpose of cleaning the physical environment and raising awareness about the significance of cleanliness and hygiene. The enthusiastic participation of students, faculty, and staff demonstrated the collective commitment to this noble cause.

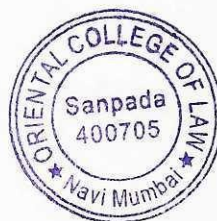

 - **Solution:** Set up additional consultation areas and used partitioning to ensure privacy and comfort for all participants.

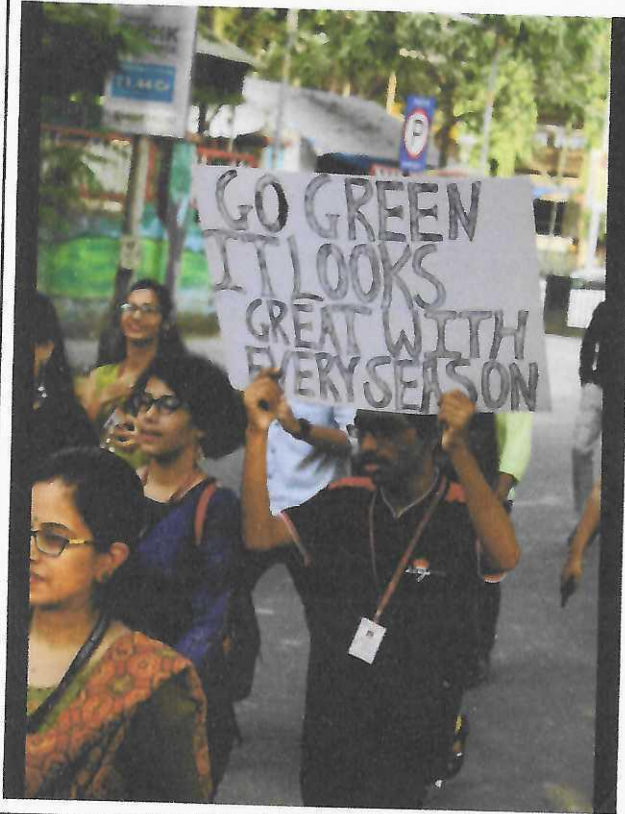


